The European Chemicals Agency (ECHA) has concluded the assessment of your inquiry dossier.

However, it remains your responsibility to decide with the other potential registrants and previous registrants whether the substances you each manufacture/import are sufficiently similar to be jointly registered.

Information on previous and potential registrants

The names and contact details of previous or potential registrants are available via the "Co-Registrants page" in REACH-IT. In accordance with Article 26(3) of the REACH Regulation, ECHA informs (if any) the potential registrants and the previous registrants having submitted data of your inquiry.

If information on a substance with the same EC/list number as listed in Article 15 of the REACH Regulation has been submitted under Directive 98/8/EC or Regulation 528/2012 concerning the placing of biocidal products on the market and the legislation on plant protection products (Directive 91/414/EC or Regulation 1107/2009), applicants² having submitted such information may also be found via the "Co-Registrants page" in REACH-IT. However, and following the end of operation of the SIEFs according to Article 29 of REACH, these applicants are not subject to the data sharing obligations under Article 27

of the REACH Regulation³. Similarly, the data they have submitted in this framework is not subject to Article 25(3) of the REACH Regulation.

Information on available data, data sharing and joint submission obligations

If information is available for this substance, you will find on the "Co-Registrants page" in REACH-IT information on the availability of studies to fulfil data requirements, as well as the contact details of the previous registrants who have submitted such studies. You will also find on the "Co-Registrants" page whether the available studies were submitted more or less than 12 years previously:

- Where a study was submitted more than 12 years previously, you will find on the "Co-Registrants" page the UUIDs of the corresponding (robust) study summaries. Pursuant to Article 25(3) of the REACH Regulation, you can use any study summaries or robust study summaries hereof for registration purposes without compensation.
- Where the information has been submitted less than 12 years earlier, you must request from the previous registrant(s) information involving tests on vertebrate animals that you require to fulfil your obligations under Article 10(a)(vi) and (vii) of the REACH Regulation. You may also request information not involving tests on vertebrate animals. You must make every effort to reach a fair, transparent and non-discriminatory agreement with the previous registrant(s) on the sharing of information and the associated costs (Article 27 of the REACH Regulation).

Based on the information on the "Co-Registrants" page, you can contact the previous registrant(s) who have submitted studies to fulfil data requirements relevant for you and initiate data sharing negotiations. You may negotiate a full data package containing all required studies with highest quality to fulfil your data requirements.

- Regarding the studies that have been submitted more than 12 years previously (specified by the UUID on the "Co-Registrants" page), you do not have to compensate the corresponding study costs. You are advised to contact the previous registrant to obtain the (robust) study summaries. You should make every effort to obtain this information from the previous registrant. If the previous registrant refuses to provide to you any of the (robust) study summaries submitted more than 12 years previously for REACH registration purposes, you may as a last resort raise the issue with ECHA's Helpdesk. Studies (if any) submitted under Directive 67/548/EEC for which no contact details are known, are attached to the present communication.
- Regarding the data submitted less than 12 years earlier, if you fail to reach agreement on the sharing of this data and its cost, you may as a last resort submit a data sharing dispute to ECHA in accordance with Article 27(5) of the REACH Regulation.

Further, pursuant to Articles 11 and 19 of the REACH Regulation, registrants of the same substance have the obligation to submit information jointly, except in cases mentioned in Article 11(3) or 19(2) of the REACH Regulation (opt-out). Even in the cases where registrants submit information separately, the dossiers of all registrants must still be submitted under one so-called "joint submission" in REACH-IT.

Important note regarding the registration dossier you intend to submit or update

ECHA did not check the completeness or compliance of the substance identity information you provided in your inquiry dossier with the registration requirements of Article 10(a)(ii) of the REACH Regulation. Upon submission of your registration dossier, ECHA will undertake the completeness check of each registration according to Article 20(2) of the REACH Regulation. Following registration, a compliance check may take place as part of dossier evaluation (Article 41 of the REACH Regulation).

Please further note that according to Article 10(a)(ii) in conjunction with Annex VI Section 2 of the REACH Regulation the substance identity information submitted in the registration dossier (including the analytical data) must be generated on the substance as manufactured or imported by your legal entity. Following registration, you may be requested to provide justification on the analytical data submitted in your registration dossier.
